Notice to Consultants

The City of Gridley (City) is requesting proposals (RFP) for Professional Design Services.

The Central Gridley Pedestrian Connectivity and Equal Access Project – Preliminary Engineering Services in the City will be funded with Federal dollars requiring the Consultant to follow all pertinent local, State, and Federal laws and regulations. **The DBE goal for this project is 20%.**

The proposals submitted in response to this RFP will be used as a basis for selecting the Consultant for this project. The Consultant's proposal will be evaluated and ranked according to the criteria provided under Evaluation Criteria of this RFP. In person interviews are not anticipated at this time.

Total amount payable to the Consultant shall not exceed \$140,000 and with a performance period of the contract from the date approved by City Council to Wednesday, June 1, 2022.

PROJECT DESCRIPTION AND BACKGROUND

This RFP relates to Professional Design Services relating to the Central Gridley Pedestrian Connectivity and Equal Access Project.

The Project addresses existing gaps in active transportation facilities in central Gridley, with a focus on streets surrounding McKinley Elementary and Sycamore Middle School that serve as major routes for students walking to and from school. Gaps include lack of sidewalks, curb ramps, detectable warning surfaces on curb ramps, and crosswalks.

The project would close gaps by installing new curb, gutter and sidewalk where needed. The project will also install driveway, new ADA curb ramps, retrofit existing curb ramps that might only require detectable warning surfaces and stripe crosswalks along Sycamore, Magnolia, Indiana, and Vermont streets in the central blocks of Gridley.

Improvements are expected to increase safety for active transportation users, especially students walking and biking to and from McKinley Elementary and Sycamore Middle School. The improvements will also make Gridley's streets more accessible for people using wheelchairs and other mobility devices.

The City will request Active Transportation Program (ATP) construction funding to supplement the funded Preliminary Engineering portion of the project. The project scope map from the ATP application is included electronically as Attachment 2 of this RFP. The purpose of this Professional Design Services project requested by the City is to bring the project to a construction ready state.
