

3. Approve Resolution No. 2016-R-001: A Resolution of the City Council of the City of Gridley Authorizing the City Administrator to Execute a Second Phase Agreement for Renewable Energy Power Purchase Agreement with the Northern California Power Agency

Interim Administrator Price reviewed the staff report. As a member of NCPA and under current law, the City is required to serve at least 33% of their end-use load using eligible renewable energy resources by 2020. To assist members, NCPA published a Request for Proposal (RFP) for renewable energy supply from solar photovoltaic facilities. The attached Agreement provides funding for NCPA to engage in negotiations of a purchase power agreement with one or more of the RFP respondents. The total cost of the project is \$35,000 and will be allocated based on participation percentages to the signatories of the agreement.

4. Discussions with Cal Trans on the State Route 99 & Cherry Street Crossing Project

Councilman Draper addressed this item stating that this issue has been in the works for a couple of years. He spoke with Caltrans regarding the safety of the intersection and they had developed a plan for an island, ADA improvements and lights in order to make the intersection safer. Caltrans did not have the budget for it in 15/16 so they were looking to Gridley to fund the project. At that time is was approximately \$38,000. Gridley didn't have it either, so it was eventually dropped. In more recent conversations, Caltrans has mentioned it would now cost around \$70,000 and they have some funds in their 16/17 budget. They would want Gridley to contribute \$10,000 and the project could have a start date of May 2017.

There was brief discussion on the City's ability to pay, what fund the money could come from and whether or not it was the City's responsibility to contribute since it is Caltrans jurisdiction. The general consensus was that something needs to be done to make the intersection safer.

Councilman Draper asked that this item be placed on the next agenda and he will come back with more details.

This was an informational item only, no action was taken.

William White, 410 Haskell Street, stood and asked to address the issue. He spoke of his own experience using the crosswalk as well as driving through the intersection. He stated he would like to see more police presence in the area.

Public Works Department Monthly Report February 2016

1. WATER:

Public works repaired water leaks at these locations:

187 Maine St., replaced cracked gate valve with new ball valve.

1054 Jackson St., repaired leak in service line.

929 Virginia St., replaced ball valve.

1965 N. Pintail Ct., Replace cracked ball valve.

Water meters that did not read were checked for problems with the ERTS (Encoder Receiver Transmitters) or Registers that had stopped working. Re-reads were done and repairs to the water meters were made.

Fire Hydrants with sub-standard fire hose connections, no isolation valve, or leaking with no repair parts available anymore are being marked to be replaced during this year's fire hydrant replacement program.

Water valves were exercised in accordance with the valve exercising program. Water valve exercising maintenance program goals: All water valves in the water distribution system shall be exercised a minimum of once every 5 years. The goal of the maintenance program is to insure that all valves are operable and that they are in the open position, and to dislodge any debris that may be in valve seat.

Water parts were organized and ordered as needed for service and inventory.

2. SEWER:

Sewers are checked on Tuesdays and Fridays. Public Works responded to these sewer issues during the weekly check of the sewer collection system:

There was 3 sewer plugs found during the weekly check of the sewer collection system:

Spruce and Hazel alley between Haskell and Jackson St., crew had to rod 360' rags were the problem.

1013 Sage St., Crew had to make a repair of the sewer lateral next to the curb and gutter.

441 Kentucky St., City crew were called to check on a sewer problem.

Public works crews have been hydro flushing sewer lines with the Vac-Con sewer truck.

Once the collection lines have been cleaned the City crew performs a CCTV (camera inspection) to evaluate the effectiveness of the cleaning operation and determine if there are any structural defects in the pipeline. If structural defects are detected, the Public Works Supervisor determines if the repair or the replacement of the sewer line can be done by the city crew or if other action is needed.

City residents are being encouraged to call the City before calling a plumber when sewer problems occur. Public Works will then assess the situation to determine if the problem is in the city sewer lines or the responsibly of the resident.

Sewer mains are routinely checked on Fridays.

Sewer System Management Plan (SSMP):

Lift station work continues on written Standard Operating Procedure (SOP) and Sanitary Sewer Overflow (SSO) response plan. Red flashing trouble warning lights and signage that read: If Red light is flashing, please call (530) 846-5678, are being installed at all Sewer lift and Pump stations. Camera and Hydro Flush sewer lines.

3. STREETS:

Public Works crews were out patching and paving streets.

Trees located on the city right-of-way, (r.o.w.) that were requested to be removed by the property owner (tree removal form), were cut down and removed by city crew. The trees had damaged curb, gutter and sidewalks and some were diseased. Round up was sprayed in alleys and other right-of-ways to control weeds.

Trees were pruned in streets and alleys at various locations.

Cutback was used to fill pot holes in streets.

Crushed rock was used to fill holes in alleys.

USA's were marked and called in, stop signs and street signs were repaired at various locations in town.

4. MAINTENANCE DISTRICTS:

City crew worked at the Heron Landing, Eagle Meadows, and the Little Ave. maintenance districts spraying, mowing, pruning and cleanup.

5. PARKS:

Park maintenance included mowing, spraying weeds, cleaning restrooms, picking up trash, watering, sprinkler repair and doing Park equipment maintenance.

6. CORP. YARD:

Equipment and vehicle maintenance work was performed. Safety meetings were held each week at the Corp Yard.

7. CURB & GUTTER:

Repairs on sidewalks were made on tripping hazards that were reported to the public works crew by grouting and grinding sidewalks. Small portions of damaged sidewalks and curb and gutter were removed and replaced with new concrete by public works crew.

8. WELL/WATER PRODUCTION:

Routine maintenance included cleaning well houses, lubricate and adjust equipment as needed, flush and clean chlorine injection valves and lines to prevent plug ups, and maintenance on fluoride injection systems.

All generators were serviced, transfer switches tested and inspected. Complete semiannual inspections of all generators and repair as needed. 10,000 gallon water tanks were flushed.

City Council

Report in Brief

The City of Gridley Council tasked the Interim City Administrator with creating a single Employment Agreement template for all appointed management employees. Currently, the positions of Chief of Police, Finance Director and Electric Superintendent are filled and have been previously appointed by City Council. Over the next several Council meetings, City Council will be asked to ratify the employment agreements of the aforementioned positions.

The employment agreements are not adding salaries or benefits to the employee's agreement, but rather formalizing the existing labor agreement into the new standards (template) format. There is no fiscal impact to revising and adopting the employee's employment agreement to the new agreement standards (template). City Council members have already reviewed the attached Electric Superintendent Employment agreement in closed session on March 7, 2016.

Employment Agreement of the Electric Superintendent

City of Gridley Employment Agreement Electric Superintendent

This Employment Agreement (hereinafter called the "Agreement") made and entered into on March 21, 2016, by and between the City of Gridley, California, a general law city, (hereinafter called the "City") and Daryl Dye, Electric Superintendent (hereinafter called the "Employee") with respect to employment as the Electric Superintendent of Gridley, California.

1. Appointment of the Electric Superintendent:

The City Council of the City of Gridley seeks to hire the Employee as the City's Electric Superintendent to serve and perform such duties at such times and places and in such a manner as the City may from time to time direct. Furthermore, the City Council of the City of Gridley is the sole appointing body of the position of Electric Superintendent, as per the adopted City ordinance(s), resolution(s) and City policy manual.

2. At Will Employment:

Employee is an "at will" employee who shall serve at the pleasure of the City Council. Accordingly, the City Council may terminate Employee's employment at any time, with or without cause. The provision may not be altered except by a written instrument by Employee, and formally approved by the City Council, which specifically references this Agreement and section.

3. Term of Agreement:

The Employee acknowledges that he serves in the position of Electric Superintendent at the discretion and pleasure of the Gridley City Council. The parties of this agreement may terminate the Agreement pursuant to the provisions of paragraphs 6 and 7 below.

4. <u>Duties and Responsibilities:</u>

- a) Employee shall serve as the Electric Superintendent of the City of Gridley and he shall be vested with the powers, duties and responsibilities set forth in the City's adopted job description for Electric Superintendent and shall be responsible for directing, administering and coordinating the electric department functions of the City of Gridley.
- b) Employee agrees to devote his productive time, ability and attention to the City business. For the duration of this Agreement, Employee shall not hold secondary employment, unless it is vocational training as it relates to electrical distribution or electrical services matters and cannot be done to encumber any City time, resources or facilities. The secondary employment must be so de minimis that it is transparent that it is for the continuing education of the Employee and to benefit the leadership and education of the Employee as the Electric Superintendent. The de minimis secondary employment shall not constitute interference with or a conflict of interest with his responsibilities under the Agreement. The City Council shall be the sole body that authorizes any de minimis secondary employment.

c) As an exempt employee and subject to City resolution regarding administrative leave, the Employee shall not receive any overtime or compensation for work performed outside of normal business hours.

5. Hours of Work:

It is recognized that the Employee must devote a great deal of time outside the normal office hours on business for the City, and to that end the Employee shall be allowed to establish an appropriate work schedule. The Employee will normally work 80 hours per (two week) pay period.

6. Performance Evaluation:

The City shall annually review the performance of the Employee subject to a process, form, criteria, and format for the evaluation which shall be mutually agreed upon by the City and Employee. The process at a minimum shall include the opportunity for both parties to: (1) prepare a written evaluation, (2) meet and discuss the evaluation, and (3) adopt an appropriate improvement plan and/or goals.

7. Termination of Employment and Severance:

- a) Per Section Two (2) of this Agreement At Will Employment Employee understands and acknowledges that Employee serves at the pleasure and discretion of the City Council and that Employee may be terminated at any time for any reason (or no reason at all) by the City Council. Except upon the event that the City terminates Employee's employment for reasons involving the alleged commission of a crime, the alleged commission of an act of moral turpitude, the alleged commission of any act constituting an abuse of Employee's public office under the laws of the State of California or the performance of an act of gross negligence (any of which shall be deemed as being reason(s) to terminate Employee's employment under this Agreement as being "for cause"), then, in all such other circumstances of Employee's termination, Employee shall receive three(3) month's severance pay. Employee understands and acknowledges that in the event City terminates Employee's employment with City "for cause" as defined above, Employee will not be eligible to receive said three (3) month severance pay.
- b) In a like manner, nothing in this contract shall interfere with the right of the Employee to resign at any time.
- c) Prior to payment by the City of any Severance, and as an express condition to receiving such Severance or Supplemental Severance, Employee shall sign and deliver to the City a waiver in the form of a release that fully releases the City (including employees, officers and agents) from any and all claims by Employee.

8. Compensation Benefits:

- a) Employee shall be paid a base salary per the current adopted salary schedule found in the most recent adopted resolution, current step(5) of \$10,333. per month effective as of the adoption date of this Agreement. The salary shall be payable in installments at the same time the other management employees of the City are paid.
- b) City shall continue to contribute the agreed upon percentage of salary to Employee's Deferred Compensation Plan (IRS 457 Plan) provided to the management group. The Employee is entitled to the earned incentives (Rubber glove, longevity, and professional certificate(s) as listed in the management group agreement. The City Council shall retain the discretion to provide additional adjustments as it sees fit depending on the performance and accomplishment of Council objectives.
- c) Consideration shall be given on an annual basis to increase compensation based upon the evaluative process discussed in **Section Six (6) Performance Evaluation** above.
- d) City shall not at any time during the term of this contact reduce the salary, compensation, or other benefits of the Electric Superintendent below the initial offer of compensation, except to the degree of such reduction for all management employees of the City. If this section is violated, such action will constitute a breach of this agreement and will be regarded as termination.
- e) Retirement: Employee shall continue to pay the Employee's Public Employees' Retirement System (PERS) contribution of seven-percent (7%) effective the first pay period after the adoption of this agreement.
- f) Sick Leave/Vacation/Holidays: Sick leave, vacation and holiday accruals and their use shall be the same as provided to management employees of the City.
- g) Health, Dental and Vision: City agrees to pay insurance premiums for health, dental and vision plans Employee participates in, including coverage for his family.
- h) Professional Memberships: Subject to approval by the City, the City agrees to provide for membership in any trade appropriate and position appropriate associations and/or organizations. The Employee is also authorized participation in two (2) conferences and meetings of organizations, which provide professional information to Employee relative to his performance as Electric Superintendent of the City of Gridley. Attendance and participation in any conference(s) or symposium(s) shall be subject to City Council approval, availability of funds and within the fiscal year's budget.
- i) Cell Phone Allowance: City agrees to provide a cell phone allowance to the Employee in an amount not to exceed seventy five dollars (\$75) per month.

- j) Administrative Leave: Per current resolution there is available to the Employee one hundred twenty (120) hours of paid administrative leave each fiscal year. All unused administrative leave shall be paid out at the standard hourly rate. There shall be no accrual of administrative leave from one fiscal year to another.
- k) Retirement Health: Employee is entitled to receive retirement health care benefits per resolution 2013-R-034.

9. Notices:

Notices pursuant to this Agreement shall be given by depositing in the custody of the United States Postal Service, postage prepaid, addressed as follows:

Alternatively, notice required pursuant to this Agreement may be personally served in the same manner as is applicable to civil judicial practice. Notice shall be deemed given as of the date of personal service or as of the date of deposit of such written notice in the course of transmission in the United States Postal Service.

10. Other Terms and Conditions of Employment:

The City, only upon agreement with the Employee, shall fix any such other terms and conditions of employment, as it may determine from time to time, provided such terms and conditions are not inconsistent with or in conflict with the provisions of the Agreement, The Gridley Municipal Code, or any other law.

11. General Provisions:

This Agreement sets forth and establishes the entire understanding between the City and the Employee relating to the employment of the Employee by the City. Any prior discussions or representations by or between the parties are merged into and rendered null and void by this Agreement. The parties by mutual written agreement may amend any provision of this agreement during the life of the agreement. Such amendments shall be incorporated and made a part of this agreement.

This agreement shall be binding upon and inure to the benefit of the successors, assigns, heirs at law and personal representative of the Employee.

If any provisions, or any portion thereof, contained in this Agreement is held to be unconstitutional, invalid, or unenforceable, the remainder of this Agreement, or portion thereof, shall be deemed severable. Shall not be affected, and shall remain in full force and effect.

Staff is continuing to provide progress reports to the City Council for the renovation of Daddow Park.

DISCUSSION

March, 2016

- The palm trees are scheduled for pruning on March 24, 2016, weather permitting. Work will be done by North Valley Tree Service.
- We are looking to move the palm trees from in front of the gazebo to the corners. To make this symmetrical, we will also move 2 others so that there are palms at the corner entries at Hazel x Virginia and Sycamore x Virginia. We are obtaining estimates from two companies and evaluating the budget to make sure this is possible.
- The Electrical Department removed the electrical lines in the park. They have designed the new underground. The schematic has been provided to Rolls Anderson Rolls to enable them to stake the conduit locations and elevation.

Daryl Dye is putting together the equipment list to order the bollards and standards. Electrical will go in prior to irrigation.

• We are making corrections to the gazebo specs and plans and they will be ready at the end of the month.

April, 2016

- Award contract for flat work
- Complete flatwork (concrete)
- Install irrigation, street trees, shrubbery; city staff
- Place brass plaques on Dit Biggs fountain

May

- Complete frontage improvements
- Complete miscellaneous items left

This schedule is very aggressive due to the limited time to ensure the work is completed. We have checked with the State and it is not possible to have an extension of time for invoicing past June 30.

Staff believes the work to accomplish the park is feasible and moving forward.



Policy


Background:

Currently the City has \$7,277,606 in LAIF, which has an interest rate of .29 percent, and \$1,000,000 in a Wells Fargo savings account, which has an interest rate of .43 percent. Annual income from these investments ranges between \$20,000 and \$30,000, depending on what time of year the money is taken out. The City has never had a robust investment program and currently has an opportunity to start one by beginning investing amounts in increments of \$100,000 in short-term, liquid securities which are in accordance with the City's investment policy.

Analysis:

The Federal Reserve, which represents the overnight "floor" rate which banks borrow and lend, is being raised for the first time in 10 years. This likely means that interest rates will be on the rise and hence a good opportunity to look at implementing an investment program.

Interest rates in LAIF are at an all-time low, as illustrated by the below graph:



State law, as well as the City's investment policy, states that investments shall be made in accordance with the following criteria:

A. Safety: Protect, preserve and maintain cash and investments placed in their trust on behalf of the citizens of the community.

- B. Liquidity: An adequate percentage of the portfolio should be maintained in liquid short-term securities, which can be converted to cash if necessary to meet disbursement requirements. Since all cash requirements cannot be anticipated, investments in securities with active secondary or resale markets is highly recommended. Emphasis should be on marketable securities with low sensitivity to market risk.
- C. Yield: Yield should become a consideration only after the basic requirements of safety and liquidity have been met.
- D. Market-Average Rate of Return: The investment portfolio shall be designed to attain a market-average rate of return throughout budgetary and economic cycles, taking into account the agency's risk constraints, the cash flow characteristics of the portfolio, and State and Local laws, ordinances or resolutions that restrict investments.
- E. Diversification: The investment portfolio will be diversified to avoid incurring unreasonable and avoidable risks regarding specific security types or individual financial institutions.

With investments, the higher the risk, the higher the return. This is illustrated by the City's existing investments – LAIF and savings accounts are some of the lowest interest rates possible, yet they are also some of the most secure investments possible. A good starting point for implementing an investment program is considering Certificates of Deposit (COD). CODs offer the credit quality of a highly secure treasury bond, but also offer the same return as a corporate bond. CODs are fully FDIC insured, which will have a positive impact on the City's note disclosures. State law limits investments CODs to 30 percent of the total investment portfolio. In our case, the maximum that would be taken out of LAIF and deposited into CODs would be \$2 million.

There are a number of investment brokers in the market which can guide the City in securing the CODs. Many of them can have a propensity to push mechanisms which do not meet the above investment criteria on clients. Therefore, brokers will be selected on reputation and interpersonal skills. There is no cost to the City for securing the services of a broker. As a result, the City would not need to go through a competitive bid process.

Fiscal Impact:

With this opportunity, The City has a possibility to at least double its return on investment for this cash. Below is a representation of the possible COD mechanisms:

Recommendation:

It is recommended that the City Council adopt a Resolution authorizing the Finance Director to begin an investment program as outlined above and choose a broker which will enable the City to be in compliance with its investment policy and state law.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GRIDLEY AUTHORIZING THE FINANCE DIRECTOR TO INVEST FUNDS AND CHOOSE AN INVESTMENT BROKER IN ACCORDANCE WITH THE CITY'S INVESTMENT POLICY

WHEREAS, the City only secures investments in LAIF and a Wells Fargo savings account; and

WHEREAS, the City has an opportunity to be in compliance with its investment policy by diversifying its portfolio; and

WHEREAS, portfolio diversification is achieved by securing investments which meet the safety, security and yield requirements of the City's investment policy; and

WHEREAS, the City intends to take advantage of an investment broker to provide these investment opportunities to generate additional interest income.

NOW, THEREFORE, BE IT RESOLVED that the City Council of Gridley hereby authorizes the Finance Director to invest cash in accordance with the City's investment policy, and that the Finance director is authorized to choose an investment broker which will provide these investment opportunities.
