F. ITEMS FOR COUNCIL CONSIDERATION

11. Interim Urgency Ordinance No. 815-2016: An Interim Urgency Ordinance of the City Council of the City of Gridley amending Title 17, Chapter 17.66, "Special Situations", of the Gridley Municipal Code related to the cultivation, dispensing, processing, and delivery of marijuana. (Citywide)

Donna Decker provided Council with a summary of the staff report. On January 1, 2016, three new medical marijuana regulations known as the Medical Marijuana Regulation and Safety Act (MMRSA) became effective. Since the City presently prohibits medical marijuana dispensaries in all its zoning districts, the new licensing provisions of the laws do not apply to the City. However, one of the new provisions requires the City to take action to prohibit the processing, transport, and delivery of medical marijuana in all zoning districts. Chapter 17.66 of the Gridley Municipal Code (GMC) currently prohibits marijuana dispensaries, collectives, cooperatives or cultivation in all zones of the City. However, it does not address the processing, transport, or delivery of marijuana to, from, or within the City limits. If local governments want to regulate any aspect of medical marijuana, it must have ordinances to regulate marijuana in effect on or before March 1, 2016. The City retains the right to further regulate the processing, transport, and/or delivery within the city limits if the ordinance is effective on or before March 1, 2016. Staff recommends the City Council adopt the Interim Urgency Ordinance 815-2016. The ordinance will become effective immediately.
