NATIONAL SEXUAL ASSAULT AWARENESS MONTH April 2019

WHEREAS, April is National Sexual Assault Awareness Month (SAAM). This proclamation calls attention to the fact that sexual violence is widespread and impacts every person in this community. The goal of SAAM is to raise public awareness about sexual violence and educate communities on how to prevent it. Rape, sexual harassment and others forms of sexual violence harm our community, and statistics show one in five (5) women and one in sixty-seven (67) men will be raped at some point in their lives.

WHEREAS, child sexual abuse prevention must be a priority to confront the reality that one (1) in six (6) boys and one (1) in three (3) girls will experience sexual assault before age eighteen (18). On campuses, one in five (5) women and one in sixteen (16) men are sexually assaulted during their time in college.

WHEREAS, the theme of this year's SAAM campaign is "I Ask". The campaign informs individuals on how they can use their words to stop sexual violence before it happens by promoting safety, respect, and equality. Our words shape the world around us. Whether you speak out against locker room talk or help someone better understand these issues, your voice is powerful and necessary in this conversation.

WHEREAS, individuals can embrace their voices to show their support for survivors, stand up to victim blaming, shut down rape jokes, correct harmful misconceptions, promote everyday consent, and practice healthy communication with kids.

WHEREAS, I join Sexual Assault Advocates and communities across the country in taking action to prevent sexual violence. April is Sexual Assault Awareness Month and each day of the year is an opportunity to create change for the future.

NOW THEREFORE I, Bruce Johnson, Mayor of Gridley, join Rape Crisis Intervention & Prevention sexual assault advocates and communities across the country in taking action to prevent sexual violence. Recommendation

Staff respectfully requests that the Mayor and City Council approve and adopt the Pledged Revenues and Funds Resolution and the Reimbursement Resolution for the Little Avenue Force Main and Lift Station Improvements Funding Application submittal.

Background

The Little Avenue sewer lift station and force main are in need of improvements and replacement. The City of Gridley qualifies for and is pursuing funding assistance through the State of California Water Quality Control Board (Water Board) Clean Water State Revolving Fund (CWSRF) for design and construction of improvements to the Little Avenue Sewer Force Main and Lift Station Project. As part of the application process, the aforementioned resolutions are to be submitted to the Water Board to be eligible for funding assistance.

The Authorization Resolution (Res. No. 2018-R-012) was approved for this application on June 18, 2018.

Fiscal Impact

The City is pursuing an SRF grant to fund the project.

Compliance with City Council Strategic Plan or Budget Goals

The Little Avenue Lift Station and Force Main Project is part of the City's Capital Improvement Plan to provide am maintain reliable sewer service.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GRIDLEY PLEDGING REVENUES AND FUNDS AT LEVELS SUFFICIENT TO MEET OBLIGATIONS TO THE STATE WATER BOARD FOR LITTLE AVENUE FORCE MAIN AND LIFT STATION IMPROVEMENTS

WHEREAS, The City of Gridley (the "Entity") proposes to pledge revenues and funds from the Sewer Funds to meet obligations to the State Water Board for the Little Avenue Force Main and Lift Station Improvements (the "Project"); and

WHEREAS, the Entity proposes a commitment to collect such revenues and maintain such fund(s) throughout the term of financing and until the Entity has satisfied its repayment obligation thereunder unless modification or change is approved in writing by the State Water Resources Control Board; and

WHEREAS, the Entity proposes that the Entity's pledge hereunder shall constitute a lien in favor of the State Water Resources Control Board on the foregoing fund(s) and revenue(s) without any further action necessary; and

WHEREAS, the Entity proposes to maintain the fund(s) and revenue(s) at levels sufficient to meet its obligations under the financing agreement, so long as the financing agreement is outstanding.

WHEREAS, the City Council has made the following findings with respect to the Project:

The City of Gridley hereby dedicates and pledges revenues and funds from the Sewer Funds to payment of any and all Clean Water State Revolving Fund and/or Water Recycling Funding Program financing for the Project. The Entity commits to collecting such revenues and maintaining such fund(s) throughout the term of such financing and until the Entity has satisfied its repayment obligation thereunder unless modification or change is approved in writing by the State Water Resources Control Board. So long as the financing agreement(s) are outstanding, the Entity's pledge hereunder shall constitute a lien in favor of the State Water Resources Control Board on the foregoing fund(s) and revenue(s) without any further action necessary. So long as the financing agreement(s) are outstanding, the Entity commits to maintaining the fund(s) and revenue(s) at levels sufficient to meet its obligations under the financing agreement(s).

NOW THEREFORE, BE IT RESOLVED that the City Council does hereby pledge revenues and funds at levels sufficient to meet obligations to the State Water Board for project funds provided for the Little Avenue Force Main and Lift Station Improvements.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GRIDLEY ADOPTING OBLIGATIONS TO REIMBURSE THE STATE WATER BOARD FOR PROJECT FUNDS PROVIDED FOR THE LITTLE AVENUE FORCE MAIN AND LIFT STATION IMPROVEMENTS

WHEREAS, the City of Gridley ("the Agency") desires to finance the costs of constructing and/or reconstructing certain public facilities and improvements relating to its water and wastewater system, including certain treatment facilities, pipelines and other infrastructure (the "Project"); and

WHEREAS, the Agency intends to finance the construction and/or reconstruction of the Project or portions of the Project with moneys ("Project Funds") provided by the State of California, acting by and through the State Water Resources Control Board (State Water Board); and

WHEREAS, the State Water Board may fund the Project Funds with proceeds from the sale of obligations the interest upon which is excluded from gross income for federal income tax purposes (the "Obligations"), and

WHEREAS, prior to either the issuance of the Obligations or the approval by the State Water Board of the Project Funds the Agency desires to incur certain capital expenditures (the "Expenditures") with respect to the Project from available moneys of the Agency; and

WHEREAS, the Agency has determined that those moneys to be advanced on and after the date hereof to pay the Expenditures are available only for a temporary period and it is necessary to reimburse the Agency for the Expenditures from the proceeds of the Obligations.

WHEREAS, the City Council has made the following findings with respect to the Project:

- 1. The Agency hereby states its intention and reasonably expects to reimburse Expenditures paid prior to the issuance of the Obligations or the approval by the StateWater Board of the Project Funds.
- 2. The reasonably expected maximum principal amount of the Project Funds is \$1,500,000.
- 3. This resolution is being adopted no later than 60 days after the date on which the Agency will expend moneys for the construction portion of the Project costs to be reimbursed with Project Funds.
- 4. Each Agency expenditure will be of a type properly chargeable to a capital account under general federal income tax principles.
- 5. To the best of our knowledge, this Agency is not aware of the previous adoption of official intents by the Agency that have been made as a matter of course for the purpose of reimbursing expenditures and for which tax-exempt obligations have not been issued.

- 6. This resolution is adopted as official intent of the Agency in order to comply with Treasury Regulation §1.150-2 and any other regulations of the Internal Revenue Service relating to the qualification for reimbursement of Project costs.
- 7. All the recitals in this Resolution are true and correct and this Agency so finds, determines and represents.

NOW THEREFORE, BE IT RESOLVED that the City Council does hereby adopt obligations to reimburse the State Water Board for project funds provided for the Little Avenue Force Main and Lift Station Improvements.

Recommendation

Staff respectfully requests that the Mayor and City Council acknowledge and accept the Annual Audit through adoption of Resolution No. 2019-R-001: A Resolution of the City Council of the City of Gridley Accepting the Independent Audit Report for Fiscal Year 2017-2018.

Background

The City's third-party Independent Auditor, Mann, Urrutia, Nelson, CPAs & Associates, LLP, has completed the audit of the financial statements for the 2017-2018 fiscal year. The audited financial statements have been distributed to the Mayor and City Council for your review. The Independent Auditor has provided a "clean" audit free of any findings. While the report is lengthy we suggest that the most interesting portions of the audit are the Management Discussion and Analysis on pages 3 through 13 and the accompanying notes to the financial statements on pages 28 through 63.

Derived from the same underlying basic financial statements information as the City's Budget Reports which are reported on separately, the Audited Financial Statements differ significantly in the presentation of that information. The City's Budget Reports are presented primarily on a cash basis to show the operating capabilities of each of the operational funds of the City during a single period. The Audited Financial Statements, based on "generally accepted accounting principles" (GAAP), promulgated by the Governmental Accounting Standards Board (GASB), focus more on presenting an overall picture of the financial position of the City.

The primary purpose of an independent audit is to assure the users of the financial statements that they can rely on those statements to accurately present the financial status of the City. The audit is not a guarantee that the statements are absolutely perfect, nor that there have been no defalcations or misappropriation of City resources. The Auditor's Report states that after studying and analyzing the City's financial records, using their expertise, accepted standards, and due diligence, they have reached the conclusion that the financial statements "present fairly, in all material respects, the respective financial position of the governmental activities, the business-type activities, each major fund, and the aggregate remaining fund information of the City of Gridley..."

The published financial statements also include as Supplementary Information, Budget Comparison Schedules, which are similar to our Final Budget Report, and Combining Statements which details the underlying non-major Fund information that makes up the Governmental Activities

The opinion on the City of Gridley's Financial Statements was considered unqualified, or in layman's terms, a clean audit. The auditors have considered the City's own internal control mechanisms to ensure that financial transactions are reported accurately, and defalcation and malfeasance do not occur. The "Report on Internal Control Over Financial Reporting..." states that this year they "did not identify any deficiencies in internal control over financial reporting that we consider to be a material weakness." A "material weakness" is a deficiency or combination of deficiencies in internal control

such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected in a timely basis.

Additionally, the results of the audit "disclosed no instances of noncompliance or other matters that are required to be reported under Governmental Auditing Standards."

Government code and practice requires that the City Council formally accept the independent auditor's report. By the very nature of the independence of the auditor, the City cannot alter or change the reports, so the purpose of the practice is only to ensure that the governing body has been presented with the report. Staff recommends adoption of Resolution No. 2019-R-001 accepting the audit report.

Fiscal Impact

There are no direct financial impacts associated with the City Council's acceptance of the independent third party annual audit process.

Compliance with City Council Strategic Plan or Budget Goals

The City Council and City staff are committed to provide the best possible financial practices and the highest possible transparency regarding all financial transactions.
