AGE:

Must be between 14 and 21 years of age.

**EDUCATION:** 

Minimum 2.0 academic grade point average prior to and maintained after

appointment.

PHYSICAL FITNESS:

Good physical and mental health.

COMMUNICATION

Applicant must be must be able to communicate effectively in written and spoken

English.

**AVAILABILITY:** 

Applicant must be able to volunteer a minimum of 5 hours a month to the

Explorer program.

OTHER REQUIREMENTS: Possess the qualities of honesty, maturity, self-discipline and initiative. Have a desire to learn. Make a commitment to volunteer time to serve the agency and community. Have parent / guardian approval to participate in Explorer activities.

#### APPLICATION PROCESS:

- 1. Complete Law Enforcement Explorer Application. When application is complete, seal in manila envelope write "ATTN: Explorer Coordinator" on front and return to the GBPD. Copies of the applicable items listed below shall be attached to the application:
  - Most recent copy of academic grades High School/College
  - Copy of High School Diploma/GED
  - Transcript of college credits
  - Copy of driver license
- 2. Oral interview.
- 3. Background Investigation is conducted to include criminal records, police contacts, driving record, and interviews with associates, references, neighbors, and other pertinent sources.

## APPLICANT DISQUALIFICATION FACTORS:

Applicants are advised that areas for disqualification from further consideration include, but are not limited to, the following:

- A. Current use of non-prescribed or illegal drugs, or abuse of prescription drugs.
- B. Any felony conviction, some misdemeanor convictions, to include domestic violence charges.
- C. Police history type, frequency and nature of contacts(s).
- D. Driving Record.
- E. Outside activities, which may be classified as a conflict of interest
- F. Revelation of assaultive behavior via background investigation or by the admission of the applicants
- G. Unsuccessful completion of any basic requirement.
