Background/Conditions

The City of Gridley recognizes the need for its citizens to use their residence for some limited activity other than a residence. However, the City believes that the need to protect the residential integrity of its living area is of paramount concern. A "Home Occupation" permit is the method used to allow and to control activity within the City's residential districts.

In essence, the objective of a "Home Occupation" permit is to allow a limited commercial-type activity in a residential area (other than R-3 zoning districts), only to the extent that, to all outward apearance, no neighbors or passersby will be aware of the activity.

"Home Occupation" permits may be reviewed annually prior to issuance of busines license.

- A home occupation is permitted as an accessory activity to any dwelling unit, subject to the following conditions:
 - A. The business shall be conducted entirely within the dwelling or accessory building.
 - B. Employment shall be limited to members of the family residing on the premises, and to one additional non-resident employee.
 - C. The total floor area used for the home occupation, including area within the accessory buildings, shall be less that 40% of the gross floor area of the dwelling unit.
 - D. Signs shall be limited to one unlighted sign, but not more than four square feet in area. Such sign may be attached flat on the building wall or may be located elsewhere on site, but not on an easement, or public right-of-way. Minimum setback shall be 10' from street curb.
 - E. The use shall not generate traffic, noise, vibration, dust, odor, heat, light, glare, electrical interference, solid waste, or other characteristics in excess of that customarily associated with similar residential uses in the general vicinity.
