Merger/Lotline Adjustment Regulations

Submittal Requirements

The following information and materials must accompany an application at the time of submittal. Applications will not be considered complete nor will they be acted upon until all submittal requirements have been met.

Planning Department

The following items must be submitted

£ Completed Application

- £ A Title or Map Report dated within 6 months of the application submittal, showing all affected owners and all exceptions.
- $\pounds \qquad \text{An 8 } \frac{1}{2} \text{ x 11" or 11" x 14" site plan of existing development, particularly the location of easements and structures and their relationship to property lines.}$
- \pounds Other information pertinent to the project should also be shown.
- £ A legal description for all of the *resulting* properties as merged or otherwise modified.
- £ Application Fees (make checks payable to the City of Gridley)

Additional information may be required to determine if significant adverse environmental impacts could result from the proposal.

Approval Process/ Time Limits

The total time required for the City of Gridley to process a Merger/Boundary Line Adjustment/Certificate of Compliance application is usually less than 30 days. However, pursuant to California Government Code Sections 65943 and 65950, the City has 30 days from the date of submittal to determine if an application is complete; and six months from the date of complete application to take final action.

Applications for a merger / boundary line adjustment are approved by City staff and then transmitted to a title company of the applicant's choice with the following instructions:

- -- Prepare deeds that reflect the approved new property descriptions, and/or obtain notarized signatures of all owners and trustees.
- -- Segragate taxes as may be necessary.
- -- Record deeds and/or certificates .
