- **Drop box** (along the alley, behind City Hall), please note: **delinquent bills should not be placed in the drop box, please pay in person OR notify us via phone.**

**Please be advised:** We do not take any payments over the phone. If anyone calls you requesting payment, please do not provide information and confirm with Gridley Utilities. **If you wish to pay by phone you may call - (877) 812-3499 for payments.**

**Utility deposits:** Required for customers that have not established a good credit history with the City of Gridley. Deposits are returned after 3 years of good payment history (with a record of no disconnection or late notices on file).

**Animal Shelter:** (530) 846-4825 - Licensing applications can be picked up at the Animal Shelter door or online via City website. You will need a current rabies certificate per individual dog, dues owed and return to the Animal Shelter drop box or via mail.
